General History

According to the merchant 'Girardo & Co. Ltd.' of United Kingdom: 'This Citroën ZX Rallye Raid is designated with the internal number C05 and was a works Citroën Sport entrant in the 1991, 1992 and 1993 Paris-Dakar Rallies. Its competition résumé comprises also of two entries in 'Rallye de Pharaons' for 1990 and 1991, all contested under the works banner. It had been subjected in 2011 to a nut-and-bolt restoration by the French ZX Rallye Raid specialist Philippe Gache's 'Team SMG Challenge'.

Notes

This vehicle was first registered on 18/07/1994, according to the French registration document and the last registration number was 'GH 510 MK'. It was imported into Greece and received a 'Customs Clearance Certificate' by the Greek Customs Authority, on 31/10/2022.
